

THE SANTA CLARA CITY COUNCIL MET ON JULY 26, 2010. THE MEETING WAS CALLED TO ORDER AT 6:32 BY MAYOR DAVID MUELLER WITH COUNCILMEN PRESENT JIM FOLBRE, GRANT HODGES, HARRELL FELIX AND TOM OWENS DAVID CALE WAS ABSENT. THE MEETING WAS OPENED WITH THE PLEDGE OF ALLEGIANCE,

CITIZENS TO HEARD:
TRACY JONNASSEN WAS SIGNED UP BUT WAS NOT PRESENT.

COUNCILMAN FOLBRE MADE A MOTION TO APPROVE THE MINUTES FROM JUNE 28, 2010. GRANT HODGES SECONDED THE MOTION. MOTION CARRIED.

COUNCILMAN FOLBRE MADE A MOTION TO APPROVE THE MINUTES FROM JULY 12, 2010. GRANT HODGES SECONDED THE MOTION. MOTION CARRIED.

COUNCILMAN FOLBRE MADE A MOTION TO APPROVE THE FINANCIAL REPORT. COUNCILMAN OWENS SECONDED THE MOTION. MOTION CARRIED.

MAYOR MUELLER EXPLAINED THE BEGINNING OF THE CITY. THE CITY COULD NOT HAVE MORE THAT 1280 ACRES. THE COUNCIL APPROVED THE BOUNDARIES ON OCTOBER 13, 1999. THE CITY HAS HAD ONE ANNEXATION WHICH IS PRISCILLA MAGAROURK. ONE DE-ANNEXATION OF 46 ACRES BACK TO THE CITY OF CIBOLO. THE COUNTY GAVE THE CITY THE ROADS IN 2004-2005. THE CONTRACT WITH GPP WAS FOR 15 YEARS. THE COUNTY PAID FOR THE FIRST ELECTION HELD AND PANDA PAID THE SCHULZ GROUP FOR THE SURVEY. J R PEREZ, COUNTY ELECTION JUDGE GENERATED A LIST OF VOTERS. GRANT QUESTIONED THAT SOME CITIZENS WERE TOLD THEY WERE NOT IN THE CITY AND COULD NOT VOTE. JIM FOLBRE SPOKE ABOUT THE STATUE OF LIMITATIONS HAVING EXCEEDED THE TIME. ASS'T COUNTY ATTORNEY ETLINGER SAID IT WOULD HAVE TO BE A HIGHER AUTHORITY TO RULE ON QUESTIONS. A HIGHER AUTHORITY WOULD BE A DISTRICT JUDGE. COUNCILMAN HODGES MADE A MOTION TO FORM A COMMITTEE TO LOOK INTO THIS MATTER DIED FOR LACK OF MOTION.

MAYOR MUELLER HAD A MAP ON DISPLAY WITH THE LOCAL JURISDICTION AND ETJS. THE CITY OF SAN ANTONIO HAS GIVEN THE CITY OF CIBOLO ABOUT 2200 ACRES THIS WILL EXTEND TO IH10 AND ALONG SANTA CLARA ROAD AND THE CITY OF SANTA CLARA'S ETJ. HE REPORTED THAT THERE ARE 226 HOMES IN THE CITY AND 99 HOMES OUT OF THE CITY LIMITES. HE REPORTED THAT HARVEST HILLS AND SANTA

CLARA BEND ARE NOT IN THE CITY LIMITS. MAYOR MUELLER REPORTED THAT MR. GIESLER IS NO LONGER WITH GPP. THEY HAVE A NEW PERSON IN CHARGE OF PSEG. HE WILL BE IN CONTACT WITH HIM.

STEPHEN HANZ WITH RIVER CITY ENGINEERING HAS SENT SOME INFORMATION ON ROAD USE FEES TO MR. SCHNALL FOR REVIEW.

THERE WAS A DISCUSSION ON THE 2010/2011 BUDGET.

IT WAS QUESTIONED WHETHER TO REPAIR THE BARRICADES OR PUT UP SIGNS FOR WATER OVER ROAD.

JIM FOLBRE MADE A MOTION TO ADJOURN. HARRELL FELIX SECONDED THE MOTION.
