CITIZENS TO BE HEARD:

MARGARET DAVIS THANKED THE COUNCIL MEMBERS AND MAYOR FOR SERVING THE YEARS THEY HAD SERVED.

COUNCILMAN CALE MADE A MOTION TO APPROVE THE MINUTES FROM THE FEBRUARY 28, 2011 MEETING. COUNCILMAN OWENS SECONDED THE MOTION. MOTION CARRIED.

COUNCILMAN FOLBRE MADE A MOTION TO APPROVE THE FINANCIAL REPORT. COUNCILMAN CALE SECONDED THE MOTION. MOTION CARRIED.

CHAIRMAN PETERS GAVE A REPORT OF THE PLANNING COMMISSION MEETING. HE REPORTED THEY HAD DISCUSSED INFRA-STRUCTURE AND RECOMMEND TO THE CITY COUNCIL THE PURCHASE OF A COMPUTER SYSTEM AND INTERNET NOT TO EXCEED \$1,000.00. HE REPORTED THE ORGANIZATIONAL CHART HAD BEEN SIGNED AND IS NOW POSTED ON THE WEB SITE.

COUNCILMAN FOLBRE MADE A MOTION TO PASS THE ORDINANCE 2011-2 TO CANCEL THE UNCONTESTED ELECTION FOR MAY 14, 2011. COUNCILMAN OWENS SECONDED THE MOTION. MOTION PASSED.

A LIST OF UNFINISHED BUSINESS WAS DISCUSSED.


1. THE COUNTY ATTORNEY REQUESTED AN ORDINANCE FOR TAB (TEXAS ALCOHOLIC BEVERAGE) WHICH DENIES ALCOHOL BEING SOLD TO CLOSE TO SCHOOLS OR CHURCHES.
 2. THE CITY IS USING THE SEGUIN GAZETTE ENTERPRISE AS THE PAPER TO PUBLISH NOTICES IN.
 3. THE INVESTMENT POLICY NEEDS TO BE REVIEWED.
 4. THE CONTRACT WITH GPP WILL NEED TO BE NEGOTIATED.
