**Mayor David Mueller's Message**

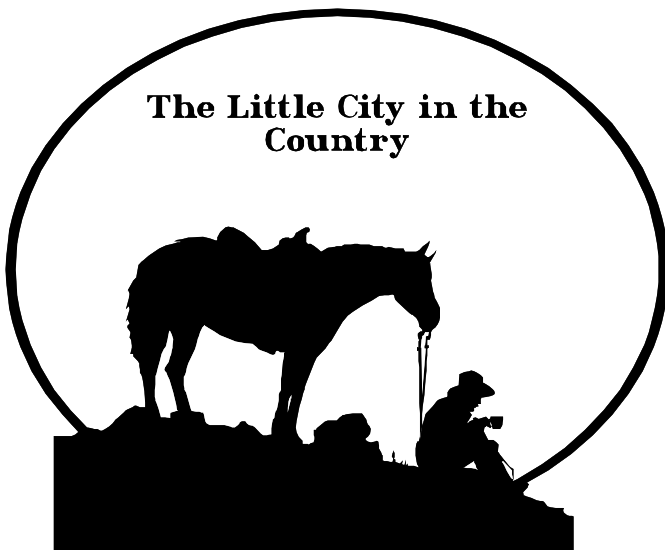

## Santa Clara City Council Update – March 2010

During the time frame this Update covers, City Council Members heard a variety of our Citizens concerns. Council Members welcomes all of your genuine interests and concerns on how we effectively manage our City business. Most inquiries were presented at the Council Meetings, during the Citizens to be heard portion of the Council Meeting. This time is devoted to hear all Citizens express their concerns, which are heard by all Council Members present. While many of the concerns may not be resolved at the attended meeting, the concerns will be officially introduced in the Council Meeting. If possible, the concern may be resolved immediately; or, as is in most cases, resolved at a later date. Unresolved issues will be discussed during regularly scheduled meetings, or the issue may be assigned to a Council Member for further research. Some issues are assigned to a Committed appointed by the City Council. The final solution to the inquiry will be available to the requestor in a meeting or a written response. A more efficient approach may be to submit your concern(s) in written form. This approach becomes an official request, which could be thoroughly reviewed and may include reference sources and other materials relevant to the requestor's point of view. Without source references, valuable time would be expended in timely research of records and files or other reputable sources. I think you see where I'm going with this. For example, if you want to know where or how your tax dollars are being spent in Santa Clara, be specific with your questioning. For example, ask how much money is being spent on Road Repairs in a month, year, etc. Or, if you have a question pertaining to a City Ordinance, Road Maintenance, City Council Meeting, Appointments to Official Positions, or how Committees are Formed, then all answers or responses can be derived at in minimal time. And, responses would be presented to you in a written response. Recently, a Citizen asked me about the City's procedure for correcting a perceived problem this individual had with a previous Neighbor. Apparently, the Neighbor moved his house from a lot next door to the concerned Citizen. In so doing, the neighbor left unsightly trash where the house used to be, and the trash has been there for several weeks. The Citizen did not understand the City's procedures for handling this kind of complaint, and getting a response to the Citizen will be delayed. Why? City Officials do now know who this Neighbor is, when and how the neighbor left, what's the address, and was the house within the City Limits. Provided with this kind of information at the time of complaint would assist in getting the proper response quicker. In summary, continue to keep your City Officials informed on all City related issues; but please prepare your inquiries properly to help us expedite a correct response.

**Dream Bars – submitted by Lorine Damerau**

½ cup butter	¼ tsp. salt
½ cup firmly packed brown sugar	1 tsp. baking powder
1 cup all-purpose flour	2 eggs
1 ½ cups shredded coconut	1 cup firmly packed brown sugar
1 cup chopped walnuts	
2 tblsp. all-purpose flour	2 tsp. vanilla extract
powdered sugar	

Preheat oven to 375 degrees. In a medium bowl, mix butter, ½ cup brown sugar and 1 cup flour with fingertips or fork until crumbly. Pat into 12 X 8 baking pan, covering bottom evenly. Bake 10 minutes; cool. In food processor or blender chop coconut into ½ inch pieces. In small bowl, beat/cream eggs, 1 cup brown sugar and vanilla. Fold coconut into creamed mixture.

Pour over cooled crust, spreading evenly. Bake 20 minutes or until golden brown and filling is set. cool slightly, while still warm, using a sharp knife, cut into 48 bars. cool in pan. Sift powdered sugar over bars.

## First Aid for Horses with Colic

**First aid:** If you come in to find your horse displaying signs of colic what to do depends on how severe the signs.

*If the signs are mild:*

1. Take away all his feed, small amounts of water are OK.
2. The next step is to take his temperature; if he has a fever (above 101) call the vet.
3. Put a lead rope on him and walk; or lunge him at a trot for about 10 to 20 minutes or go for a trailer ride for 20 min. Many mild colics will improve with either of these treatments.
4. Then put him back in the stall and watch him. If you are unsure about his condition, offer a small handful of feed and see if he will eat it. A colicky horse as a rule will not chew and swallow feed, though he may play with it.
5. If he is over his bout of colic, continue to check him frequently for 4 to 5 hrs. to make sure the pain does not return. He should not be fed for 6 hours after his appetite returns completely. He should be allowed water free choice.
6. If he remains painful or you are unsure about his condition call the vet.

Even if Old Faithful gets over his pain, talk with your vet about possible causes and prevention.

*If your horse is very painful you are going to need help:*

1. The first priority is to call the vet.
2. You would like to prevent the horse from hurting himself and one of the best ways of doing that is to walk him. If the horse is so violent that he is dangerous stay away, otherwise halter him and walk him until the vet arrives.
3. If the horse insists on lying down, that is OK so long as he does not roll. Lately many colic specialists have questioned whether rolling causes bowel twists, but until the jury is in, try to prevent it.

## **Snow in Calallen by Charles Cale**

**We lived in Calallen, Texas; my family moved there in 1936, leaving our home on David Street in Corpus Christi, Texas. I was seven years old and my brother Donald and I were both born in that David Street house. Dr. Barnard delivered Donald on Dec. 3, 1926 and I made my appearance on Aug. 22, 1929.**

**Dad, A.V. Cale, was the superintendent in charge of the ice cream section of the Borden Creamery in Corpus Christi. When he started work there it was called the Mistletoe Creamery, before Borden bought the company around 1926.**

**Mr. Gail Borden, Jr. founded the Borden Company and he was the one who discovered the process of condensed milk. Mr. Borden patented the process for condensed milk and it was in great demand during the Civil War. He was born in 1801 and was the inventor of many useful products. He died in Borden, Texas in 1874.**

**In 1936 my dad bought a dairy in Calallen from Clarence Priour. It was about 15 miles from Corpus Christi. He milked over a hundred cows and sold the milk and cream to the Borden company. Later his herd increased to 185 Jersey cows.**

**On Dec. 13, 1939 I suffered a big pain in my right side and was operated on in the Fred Roberts Hospital in Corpus Christi. My appendix was removed and I was in the hospital for about seven days.**

**A month or so later I opened my eyes to see our hilltop covered with snow. I was ten years old. In one of dad's sheds I found an old 55 gallon wooden barrel that bulged out of its middle. It was about to fall apart so I helped it.**

**I took two of the wooden staves from the barrel and some leather from an old pair of dad's boots. I made ski straps by cutting the boots with one of my mother's pairing knives and I nailed the ends of the short straps to the sides of the barrel staves so my feet would slip into them. The makeshift ski boards angled up in the front and in the back, so I could then ski over the snow.**

**Our house was on a hill and I was so excited. Leaning over I put my feet into the make-do leather straps and as I stood up the skis slipped out from under me. The pairing knife, still in my right hand, stuck in my left hand at the base of my thumb as I fell. After a trip to the house and a loving mother who bandaged my bleeding hand, I was back on the skis (without the pairing knife this time) and skied down the hill several times; I still have a scar on my left hand.**

**This was the only time I ever remember it snowing while we lived in Calallen. It snowed two or more inches and the countryside was very pretty. I have a vivid memory of this snow experience even today.**

**In 1951, when I was in the U.S. Army and stationed at Ft. Lewis near Olympia, Washington, I was able to ski on real skis in Snoqualime Pass with seven feet of snow on the ground. At Mt. Rainier, we, my Army buddies and I, skied on 10 to 12 feet of snow. It was heavenly! It had been a long period of 12 years since my first ski experience with homemade wooden skis on a tiny slope. Washington State snowfields with their unlimited slope runs were a treat for this South Texas flatlander.**

**Returning from the army in 1952, I joined my dad and mom to farm in Marion, Texas, where they moved in 1951.**

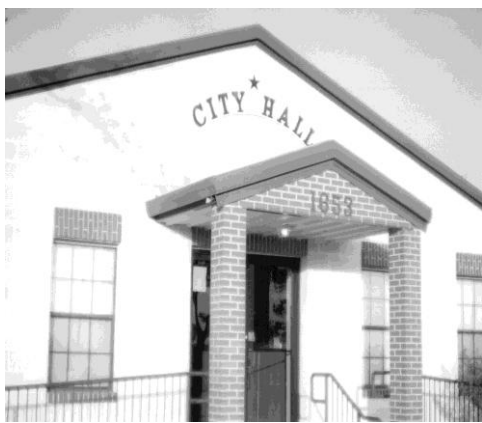
